Ipswich Women's Club Records 2012.02

History

The Ipswich Women's Club was established in March 1898. It received state federation in April 1900, and general federation in 1940. The mission of the club was "to strengthen the intellectual and moral life of its members, to promote social enjoyment and general improvement, and to benefit the community in which it is organized." Meetings were held twice a month from October to April, with the annual business meeting being the last regular meeting in the club year. A typical meeting began with club business, and concluded with a presentation for the education of the members, typically a lecture or music. Volunteer work by the members was done in youth activities, veteran service, senior citizen outreach, community improvement projects, and many other fields. The group elected officers and appointed various committees that focused on specific issues such as education, community services, music, college scholarship awards, finance, decoration, and more.

Scope and Content/Series Description

The records are divided into four series: Compiled Histories, Governance, Year Books, and Club Activities.

The Compiled Histories series consists of scrapbooks compiled by members containing newspaper clippings, programs, and photographs of club activities and members. The Governance series contains handwritten and typed constitutions, by-laws, executive board meeting minutes, club meeting minutes, and records from the club treasurer. The Year Books series contains folders of the small printed pamphlets that the Ipswich Women's Club compiled each year to list their events and their members. The Club Activities series contains ephemera and guest books that reflect club activities and interests.
